Message No.DS. 222/2015/187 dated 02.05.2016, communication from the Directorate, FCS&CA, Assam and in exercise of the powers of Licensing Authority conferred under clause-28(b) of the Assam Public Distribution of Articles Order, 1982, I, Dr. M. Angamuthu, IAS, Deputy Commissioner, Kamrup Metropolitan District Guwahati do hereby make the allocation of rice under National Food Security Act, 2013 for the Month of June, 2016 for AAY & Priority category of beneficiaries. The value deposit and lifting of NFSA rice for the month of June, 2016 is up to 31.05.2016 in favour of licensee sub wholesalers of Kamrup Metropolitan District and North-Guwahati WCCS of Kamrup District, as per breakup allocation which shall also be read with Annexure – I for Kamrup Metropolitan District only as detailed below for ultimate distribution @ 35.00 kg of rice to the AAY beneficiaries / Ration Card and @ 5.00 Kg of rice / beneficiary to the priority Ration card holder house hold at Govt. fixed price of Rs.2.00 per Kg.

Any deviation from this order shall be dealt with under section-7 of the Essential Commodities Act, 1955.


